4.	Report of Meeting with MPP Bill Walker	Steve Redmond and Guy Treadwell
	Rick Mosher and Guy Treadwell met with Bill Walker at the Lystek storefront on April 10, 2012. Brian Milne and Dave Milliner from Southgate were also in attendance as well as Steve Redmond.	
	One concern that Bill Walker had been getting from some members of the public is with the fertilizer storage lagoons and their construction and containment. Lystek reviewed the liner/cover engineering as well as the containment and monitoring system that would be in place to insure the health and safety of the Dundalk community. Once explained to Bill, he seemed to understand and feel better about the storage lagoons.	
	OPP staff happened to stop by during this meeting and indicated that if there is a Six Nations Flag flying they will not get involved with the protest unless it becomes violent. They are monitoring the situation and stated that they did not want to remove the blockade and or protestors as they have been instructed to remain neutral so as to not, cause a larger issue.	
	For the most part there have been no First Nations representatives protesting, however certain Southgate community members have apparently received permission from certain Six Nations representatives to fly their flag and represent them.	
5.	Report of Six Nations GAC meeting on April 20 Dr. Ward and Kevin Litwiller met with Chief Montour and Lonny Bomberry, Land and Resources Spokesperson of the elected council of the Six Nations of the Grand River, on April 17 th .	Steve Redmond and Guy Treadwell

On Friday afternoon members of Lystek met with

numerous members of elected council of the Six Nations of the Grand River. During this meeting they learned a lot about each other and their interests and concerns. The Six Nations of the Grand River is now seeking an independent third party review of the proposed Lystek OMRC facility development design, which is expected to be at Lystek's expense.

At the meeting Lystek was advised that there is a land dispute between the Six Nations of the Grand River and the Federal Government regarding a tract of land 6 miles wide on either side of the Grand River that runs from the mouth of the Grand River to the headwaters. The Eco Industrial Park is within this disputed land known as the Haldimand Tract.

Brochures were distributed that provide education and details of the 1784 Haldimand Treaty Land Claim and development undertaken within this tract of land.

6. Overall Update on First Nations consultation

Aboriginal Consultation is the responsibility of the Crown (in this case the MOE). The MOE has the authority to delegate certain procedural aspects of the duty to consult to the proponent while maintaining overall responsibility for ensuring meaningful consultation takes place. The MOE requested that Lystek, as the proponent, conduct an Aboriginal Assessment of the site to the MOE's satisfaction. The MOE sent out a letter of information to 11 Aboriginal Groups asking them to respond back to the MOE regarding any comments they may have by March 8, 2012. The MOE/Lystek heard back from the Historic Saugeen Metis, a letter in favour of the Lystek development which is attached to the meeting minutes.

No other responses to the MOE letter were received.

On March 12, 2012 a number of community members from Southgate attended Six Nations of the Grand River council meeting advising of the proposed Lystek development. Six Nations of the Grand then forwarded a formal letter to Southgate Council asking to meet and discuss the proposed Lystek development as they wanted to get factual information about the Lystek process and product. The above-noted meetings where in response to this invitation.

In addition to the elected council of the Six Nations of the Grand River there is another Aboriginal Group known as the Haudenosaunee Confederacy Chiefs Council (Haudenosaunee) who has advised Lystek that they also have treaty rights in the area of the Eco Industrial Park. It is understood that there are three members of the Haudenosaunee who have become aware of the Lystek project through correspondence with those same community members who attended the Six Nations of the Grand council meeting. These three members of the Haudenosaunee are Ruby and Floyd Montour and Wes Elliott. It is understood that these Haudenosaunee representatives and those community members who originally made a presentation to Six Nations of the Grand River are cooperating in blockading entrance to the Eco Industrial Park.

7. Community Advisory – Q&A Document

Questions reviewed and approved by the PAC

- What are the details regarding the exact

distances between the facility and the public school?

- How does the Lystek process work on pathogens and metals?
- Will Dundalk be a dumping ground for Toronto's waste?
- Will the Lystek facility assist Dundalk with their wastewater treatment?
- Will the Organic Material Recovery Centre (Lystek treatment facility) emit Nitrogen Oxides from its stack?
- What royalties will the township be receiving?

Moved by Sarah Mason that questions and answers that are finalized by the PAC be published as a press release in the local paper for easy access to the public. Seconded by Mary Fowler.

8. Approvals Update and status of "Shell Building Permit"

Lystek advised that the challenge to their building permit has yet to be resolved and that the court date was April 26, 2012.
